RESOLUTION 2023-04

The Board of Trustees of Miami Township, Clermont County, Ohio met in regular session at the Miami Township Civic Center on January 17, 2023, with the following members present: Mark Schulte, Ken Tracy and Mary Makley Wolff.

A motion was made to adopt the following Resolution:

RESOLUTION DESIGNATING THE PUBLIC DEPOSITORIES FOR FUNDS OF MIAMI TOWNSHIP AND AUTHORIZING THE FISCAL OFFICER AND ADMINISTRATOR TO EXECUTE APPLICABLE DOCUMENTS

WHEREAS, in accordance with provisions of the Uniform Depository Act, the Township must designate depositories of active and interim public funds; and

WHEREAS, proposals were solicited from banking institutions maintaining an office within an acceptable proximity of the Miami Township Civic Center, 6101 Meijer Dr; and

WHEREAS, proposals were received from three financial institutions; and

WHEREAS, all the proposals received were thoroughly reviewed and analyzed.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Miami Township, Clermont County, Ohio, that:

- **SECTION 1**: The Board hereby designates JPMorgan Chase and Huntington National Bank as public depositories of Miami Township of which active funds may be awarded for a period of five (5) years, for the period January 1, 2023 to December 31, 2027.
- **SECTION 2**: The Board hereby designates JPMorgan Chase, Huntington National Bank and StarOhio as public depositories of Miami Township of which interim deposits may be awarded as they become available for a period of five (5) years, for the period January 1, 2023 to December 31, 2027.
- **SECTION 3**: The Fiscal Officer and Township Administrator are authorized and hereby directed to execute agreements with the aforementioned financial institutions for depository and other related banking services.

- SECTION 4: The Board does hereby dispense with the requirement that this Resolution be read on two separate days, pursuant to Section 504.10 of the Ohio Revised Code, and authorizes the adoption of this Resolution upon its first reading.
- SECTION 5: That this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 6: This Resolution shall take effect at the earliest period allowed by law.
