## RESOLUTION 2014-16

The Board of Trustees of Miami Township, Clermont County, Ohio met in special session at the Miami Township Civic Center on April 15, 2014 with the following members present: Ken Tracy, Mary Makley Wolff and Karl Schultz

MR. SCHULTZ made a motion to adopt the following Resolution:

### **RESOLUTION AMENDING RESULTION 2014-11 PROVIDING FOR THE COMPENSATION OF TOWNSHIP EMPLOYEES**

WHEREAS, the Board of Trustees is empowered to grant compensation increases to Township employees, and

WHEREAS, various Township employees are eligible for compensation increases on January 1<sup>st</sup> of each year, via employment contract, promotion, annual merit increase, performance incentive or pursuant a collective bargaining agreement, and

WHEREAS, there was an error in the schedule attached to Resolution 2014-11, and

WHEREAS, the Board of Trustees has reviewed the proposed compensation increases as presented in the attached schedule.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Miami Township, Clermont County, Ohio by authority of Chapter 504 of the Ohio Revised Code, as follows:

SECTION 1: That the Board of Trustees amends Resolution 2014-11 a Resolution Providing for the Compensation of Township Employees, and

SECTION 2: That this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.


SECTION 3: This Resolution shall take effect at the earliest period allowed by law.
